Registration horse step-by-step

To register a horse with the Barock Pinto Studbook, we need to receive the following documentation. For a speedy registration, please keep the following points into account In the case of an incomplete of incorrect registration application, we are unable to start the registration. The registration will be returned, to be completed. All mentioned documents (with the exception of the breeding license), can be found on our website.

Completely filled out registration form of breeding license:

- A "breeding license" will be given to you by the stallion owner
- The "registration form" can be found on our website
 - o When using a registration form, an additional €30,- is charged.
- Do not forget to add the microchip sticker.
- Make sure the address information is readable and complete.

A Copy of the official pedigree of the parents:

- This is the official studbookpaper of the studbook that the parents are registered in.
 - o A print from a website is not sufficient.
- Make sure that the registration numbers are legible.
- The information for an approved BPS stallion are known to us.
- To register an older horse, please also send us a copy of the horses' passport.

DNA samples:

- A DNA sample consist of a lock of hair, with the roots attached, from the mane of tail.
 - o A DNA sample CANNOT be cut.
- A DNA sample is collected by a veterinarian of licensed micro chipper.
- A DNA sample must be accompanied by a signature of the veterinarian or licensed micro chipper.
 - o There is a specific space for this on the registration form/breeding license.
 - o For a separate send in sample, please add the "DNA statement veterinarian" form.
- A registration must include a DNA sample must include a sample for both foal and parents.
- A DNA sample must be delivered as flat as possible, for instance in an Envelope/Ziplock bag.
- The DNA information for an approved BPS stallion are on file with us.

AES sketch for the passport application:

- Only the sketch form of the AES can be processed by us.
- The "AES sketch" must be completely filled out by a veterinarian of licensed micro chipper
 - The AES sketch must include the signature and stamp of the veterinarian or licensed micro chipper.
- The drawing must be done in red, conform AES demands.
- The general information must be complete, correct and legible.
- The written description of the marking, done per body part, must be complete and in accordance with the drawing.





- o "Irregular Pinto" is NOT sufficient.
- The BPS CANNOT fill out the AES sketch for you, adding photos does NOT change this.

IFCE form (only for France):

- The AES arranges the IFCE registration directly.
- The form must be filled out completely.
- Only the IFCE document on our website "IFCE Declaration" can be processed by us and the AES.
